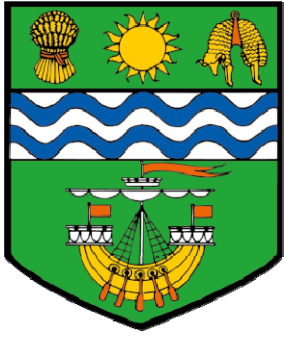
Notice or Requirement/Designation	Recommendation

SPK-1 and SPK-2	Designations be confirmed with the conditions as provided by the reporting planner in her right-of-reply

As a Requiring Authority, Clause 13(1) First Schedule RMA requires notify Central Hawke’s Bay District Council within 30 working days after receipt of this letter as to whether you accept or reject the recommendation in whole or in part. Modifications may be made only if the modification has been recommended by the Council or it is not inconsistent with the requirement as notified.
