Proposed Central Hawkes Bay District Plan – Recommendations on Notices of Requirement

This letter is to notify you of the Central Hawkes Bay District Council’s recommendation on designations that were included in the Proposed Central Hawkes Bay District Plan pursuant to cl 4(5) First Schedule, Resource Management Act 1991 (**RMA**).

Pursuant to Clause 9(1), First Schedule and s 171 RMA, the recommendations relating to Notices of Requirement by Minister of Police are summarised below. A full copy of the Council’s recommendations, including reasons for the recommendation, is [enclosed \(Panel Report 7D\)](#).

Notice or Requirement/Designation	Recommendation
MPOL-1 and MPOL-2	The Panel recommends that the designations be confirmed, with the proposed modifications.
