- **Application fee of \$244.00 (GL 7101194) applies. GST Incl.**
- The conditions set out in Schedule 3 of the "Livestock Movements and Animals in Public Places Bylaw 2008"
- Your application must be approved by the Council before you allow livestock to graze on the road reserve
- Grazing will only be permitted on road reserve adjoining the Applicants Property
- Grazing of road reserve adjoining neighbours property will only be permitted if written agreement is received from the property owner and is attached to this Application
- **The grazing permit is valid for up to one year. For further grazing an annual licence fee of \$62.00 for up to one acre (4000m²) or \$114 for larger than an acre (4000m²) (GL # 7101194) applies. GST incl.**
- All reinstatement costs to a damaged road reserve will be met by the stock owner
- Any stock found grazing the road reserve in contravention of the conditions may be removed, immediately by an Authorised Officer. Such removal may be without notice and at no cost to Council.
