**I do not support the proposed policy in the ONF chapter:**

*“To recognise the regional social and economic significance of water storage within ONF-4 (Mākāroro Gorge).”*

It is not apparent upon what basis this policy has been arrived at:

1. What is the “regional social and economic significance” of water storage within this catchment – this is not quantified?
2. Why support water storage within this catchment, and not others (this appears to simply be a Trojan Horse for monetising the Intellectual Property and consents for the Ruataniwha dam)?
3. Has any work been done, or existing reports consulted, by Council to quantify the conservation values in the Mākāroro Gorge, and further upstream in the Ruahine park conservation estate (i.e. a water storage project in this catchment would have adverse impacts on the environment, which do not appear to have been considered)?
4. Why have Council not included recognition of “environmental significance” in this policy proposal (i.e. it is possible that (i) there are no environmental benefits, and/or (ii) Council do not value the environment alongside social and economic values)?
5. Can Council confirm that a water storage project in this catchment would be consistent with the Resource Management Act (this seems improbable)?

I further petition Council to desist from any further involvement, promotion, or pecuniary support for water storage, euphemistically referred to in recent times as ‘water security’. This is a private sector concern for local agri-business to address.
