RM210103 – Notice of Rescheduled RMA Hearing – Section 95B Limited Notification pursuant to the Resource Management Act 1991 – Three Hundred and Twelve Lot Subdivision at 1200 State Highway 50 Part Section 2 Block IV Ruataniwha Survey District

Further to our correspondence dated 29 March 2022, the applicant for resource consent application RM210103 for a subdivision at 1200 State Highway 50 requested the hearing be rescheduled at a later date. This letter serves as a notice confirming the rescheduled hearing date.

As previously mentioned, pursuant to Section 95B of the Resource Management Act 1991, Council is required to notify all parties and provide them with a schedule of events once a formal hearing date has been set. If you are attending in person and wish to display your evidence on a screen at the hearing, please confirm you wish to do so when circulating your evidence in accordance with the abovementioned dates.

Procedures for the hearing of submissions may be adjusted in light of the evolving COVID-19 situation to ensure, to the extent possible, the safety of the Panel, reporting officers, supporting staff and submitters. Confirmation of the procedures and protocols for the hearings will be communicated to all submitters **two working days before the hearing or as this information is made available from Central Government, whichever is earliest**. Depending on the COVID-19 situation at the time of the Hearings, virtual appearances may be preferred, or the Hearings may be conducted entirely online.

Hearings will be conducted in line with the most current Health Order and Government guidance of the day. The Hearings Administrator will advise all parties at least **two working days or as the information is made available from Central Government, whichever is earliest**, prior to each hearing of Council requirements and obligations in regard to COVID-19 Management.
